They learned some information about what the grant reviewers are seeking and why some applications were not accepted last time. Anyone who was funded in the first round will not be eligible for the second round of funding. MVROP is thinking Ohlone College would be the best choice for the fiscal lead for the grant.

MVROP recently put on a presentation at a NHUSD Board of Education meeting sharing information about its programs and plans for the future. It was well received. MVROP is in the process of scheduling similar presentations for the other JPA Districts.
